

**WAIVER OF LIABILITY AND DISCLAIMER**  
**(READ CAREFULLY BEFORE SIGNING)**

I, \_\_\_\_\_, an individual state my desire to participate in certain activities being offered by or through Jordan Ranch, the corporate structure, its officers, directors, employees, agents, contractors, and volunteers (individually or collectively referred to as the "Ranch") and in consideration for being allowed to participate, state and agree as follows:

I have given my consent to Jordan Ranch, a Texas non-profit corporation ("Ranch") for me to participate in certain activities which carry with them a degree of risk and danger, including but not limited to Women's Retreat- KFBC (the "Event"). I am at least eighteen (18) years of age and legally competent to sign this Waiver of Liability and Disclaimer ("Waiver") on my behalf. I hereby certify that I am able to participate in the Event.

For the purposes of the following provisions, the term "Participant" refers to the participant on whose behalf this Waiver of Liability and Disclaimer (this "Waiver") has been executed.

I understand that the Event and other activities associated with the Event involve certain risks, and that injuries can occur to the Participant or other participants that may require certain first aid and/or medical treatment. In consideration of Participant being allowed to participate in the Event, I hereby acknowledge that I and, to the extent applicable, my Child assume all risk in connection with the Event for any harm, injury, or damage that may be incurred by Participant as a result of Participant's participation in the Event, including activities preliminary and subsequent to the Event, whether foreseeable or unforeseeable. I further assume all risk in connection with the Event for any harm, injury or damage that may be incurred by any other participant as a result of Participant's participation in the Event, including activities preliminary and subsequent to the Event, whether foreseeable or unforeseeable.

I understand and agree and hereby acknowledge that I will not attempt to hold Ranch or any of its employees, officers, directors, members, agents, representatives or attorneys responsible or liable in any way for any occurrences that may result in injury, death, or other damages to Participant as a result of Participant's participation in the Event. I FURTHER HEREBY ACKNOWLEDGE AND AGREE TO DEFEND, INDEMNIFY, SAVE, HOLD HARMLESS, AND COVENANT NOT TO SUE THE RANCH, ITS OFFICERS, DEACONS, MINISTERS, DIRECTORS, EMPLOYEES, VOLUNTEERS, CONTRACTORS, STAFF, AFFILIATES, AGENTS, AND ATTORNEYS (COLLECTIVELY, THE "RANCH PARTIES") AND THE PROPERTY OF THE RANCH FOR ANY CLAIM, INCLUDING CLAIMS FOR NEGLIGENCE AND GROSS NEGLIGENCE OF ANY ONE OR MORE OF THE RANCH PARTIES, BY ME, OR MY FAMILY, AND MY (OR THEIR) ESTATE, HEIRS, EXECUTORS, ADMINISTRATORS, OR ASSIGNS, ARISING OUT OF PARTICIPANT'S PARTICIPATION IN THE EVENT OR FIRST AID, TREATMENT, OR SERVICE RENDERED AS A RESULT OF OR IN CONNECTION WITH THE EVENT OR PARTICIPANT'S PARTICIPATION IN THE EVENT.

BY SIGNING THIS WAIVER, IT IS MY INTENTION ON BEHALF OF ME AND MY FAMILY, TO EXEMPT AND RELEASE THE RANCH PARTIES AND THE RANCH'S PROPERTY FROM ALL CLAIMS, CAUSES OF ACTION, SUITS IN EQUITY AND LIABILITY WHATSOEVER FOR PERSONAL INJURY, PROPERTY DAMAGE, OR WRONGFUL DEATH CAUSED BY THE RANCH OR SUCH OTHER RANCH PARTIES, INCLUDING WITHOUT LIMITATION THE NEGLIGENCE OR GROSS NEGLIGENCE OF ANY OF THE RANCH PARTIES CONCERNING OR IN CONNECTION WITH THE EVENT OR MY PARTICIPATION IN THE EVENT.

I hereby acknowledge and expressly agree that this Waiver is intended to be as broad and inclusive as permitted by, and shall be construed, interpreted and enforced pursuant to, the laws of the State of Texas and that, if any portion of this Waiver is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. This Waiver shall not terminate on the end of Participant's participation in the Event. This Waiver contains the entire agreement between me and the Ranch regarding Participant's participation in the Event.

I understand all of the statements I have made in this Waiver are contractual and not merely recitals, and that I have signed this Waiver of my own free will. **I HAVE FULLY INFORMED MYSELF OF THE CONTENTS OF THIS WAIVER BY READING IT BEFORE I SIGNED IT.**
